Question: Will there ever be an increase in the length of certification? From 2 years to 3 or 4 years?

California Title 9 regulations governing the certification of SUD Counselors requires a bi-annual certification renewal. Title 9 regulations are not likely to change in this area as bi-annual renewal is widely accepted and practiced by most certifying bodies nationally.

The mandatory bi-annual certification renewal process ensures continued growth through required continuing education. The individual's work experience gained provides an increase in their competency from initial certification. This renewal process is validated by not allowing renewal after a 2-year expiration period. Lapsed certifications exceeding the 2-years are required to meet the certification's current evolution requirements to reinstate their certificate.

Stimulant Use Prevention and Treatment in Communities of Color funding opportunity



The California Department of Health Care Services (DHCS) is using available federal grant funding to improve community access to stimulant use disorder prevention and treatment in communities of color throughout California.

There are two individual funding opportunities: 1. Stimulant Use Prevention and 2. Stimulant Use Treatment. Applications are due by May 14 at 1 p.m. The Center at Sierra Health Foundation will assist DHCS with the administration of these funds through the Medication Assisted Treatment Access Points Project.

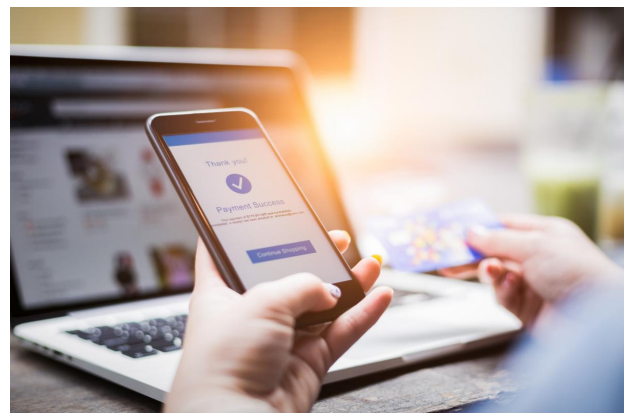
